- 1. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Buyer Added Bid Specific ATC

- 1. Brief profile of the company and evidence to establish that the bidder has successfully executed contracts of similar nature and magnitude in the last 3 years.
- 2. Audited Balance Sheet, Profit and Loss Account, Audit -Report Copy of last year certified by CA.
- 3. Attested copy of PAN No. / Tan No.
- 4. Attested copy of proof of EPF registration.
- 5. Attested copy of proof of ESIC registration.
- 6. Attested copy of proof of service tax registration /GSTIN Number.
- 7. ISO certified copy of certificate should be attached with bids, otherwise bid will be rejected.
- 8. The agency/firm/company is neither blacklisted by any central/state government/ Autonomous Bo dy/PSU nor is any Criminal case registered against the Agency/Firm / Company. Undertaking of no t blacklisted will attached on Technical Bids on company letter head otherwise bid will be rejecte d.
- 9. A pre bid meeting will be organized on 12.02.2025 and timing will be 11:00 AM, after the said tim e no agency will be entertained and those who would present in the meeting only will be preferre d and considered for technical Evaluation and DESHBANDHU COLLEGE may issue the Pre-bid Parti cipation certificate to the participated agency, and which is to be uploaded along with their docu ment to qualify the Technical Criteria, otherwise bids will be rejected and the Pre-bid certificate w ill be issue only to those who will meet all terms and condition of bid.
- 10. The bidder shall submit tender documents along with certificates in hard copy at DESHBANDHU C OLLEGE office before bid end date, otherwise bid will be rejected
- 11. Bidder should have experience providing similar services to government educational institutions a nd the physical copy of the work order will be verified at the time of Pre bid meeting otherwise bid will be rejected.
- 12. Should have done at least 1 project of Minimum 50 Housekeeping Manpower. Security and other contracts will not be considered.
- 13. After completion on initial contract period, upon satisfactory performance contract can be mutuall y increased offline for another years.
- 14. Agency should have Training Infrastructure Facility- Validity of the same will be verified with original physical copy that will be verified only at the time of Pre-Bid Meeting, otherwise bids will be rejected.
- 15. Geographical Presence in consignee state i.e. Agency should have min 2 offices, one should be in Delhi and other may be in Delhi/NCR, proof of the same should be enclosed with the bid and the physical copy of the shop and establishment will be verified at the time of Pre bid, and the date of the same should be before the date of Floating the Tender otherwise bid will be rejected.
- 16. Customer/ Client base (PSU's/PSB's to be preferred) Min 5 Clients work order required during last 3 years, otherwise bids will be rejected.
- 17. The registered company, firm or an agency shall be having at least an experience of One similar work costing not less than Rs. 40,00,000/- (Rs. Forty Lakhs only) per annum in housekeeping services during the last Three years. The company must attach work order from the concerned department.
- 18. The tenderer shall have minimum average annual turnover of Rs.2,20,00,000/- (Two crore twenty lakh only) per annum for the preceding three financial years.
- 19. The tenderer must be working at present in at least Three Government Department/ Pu blic Sector Undertaking in Housekeeping Services, physical copy of the work orders will be everified at the time of Pre-Bid.
- 20. Agency should quote min Rs 9000/- for Housekeeping material.
- 21. College reserves the right to serve 30 days notice period to Agency, if fails to perform as per the college requirements.

Note:- if any of the above conditions fails to comply then the bidder will be considered technically disqualified.

5. Service & Support

6. Service & Support

7. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

8. Purchase Preference (Centre)

Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar/URC for that product/service category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
