I further undertake that any lapse or violation on my part in complying with the said Code of Conduct shall render me liable for disqualification from contesting the election and/or such other action as may be permissible under the applicable rules.

6. That I have filled the nomination form myself for submission to Returning Officer Deshbandhu College Student Union Election 2026-27 in my own handwriting; attached the requisite documents duly self attested and paginated, namely:

(a) Fee slip/slips for the academic session 2026-2027;

(b) Date of birth certificate;

(c) Copy of the mark sheet of the last examination;

(d) Duly renewed College Identity Card, or verification of my particulars and photograph on plain paper by the concerned Course Dealing Assistant;

(e) Supporting documents for proposer and seconder

7. That I have no previous criminal record, have not been subjected to any disciplinary action by the Delhi University/ Deshbandhu College, and have not failed in the preceding academic year and/or been re-admitted in the current academic year.

8. That I and my supporters shall not indulge in defacement of College property, disturbance of classroom teaching or disruption of the academic atmosphere of the College during or after the course of the elections, and that in the event of my involvement in defacement of property, I shall stand disqualified from contesting the elections.

That I undertake to respond to any communication/email sent by the Deshbandhu College Office in connection with the election or compliance with the Election Code of Conduct **within 24 hours** of receipt thereof, failing which I shall be liable to such ex-parte action as may be permissible under the applicable rules in case of any violation of the Election Code of Conduct.

14. That I shall ensure that neither I nor my election agents, supporters or persons acting on my behalf indulge in any act prohibited under the applicable election rules, Code of Conduct, University regulations or directions issued by the competent authority.

15. That I will be finally contesting for a single post only. I am aware that in the event of my valid nomination(s) on more than one post after expiry of withdrawal, my candidature(s)/nominations from all posts will be cancelled without notice.

16. That all the statements made hereinabove are true and correct to the best of my knowledge and belief, and no material fact has been concealed or suppressed.
